AIMS AMP Capital Industrial REIT launches customised tenant solution for 26 Tuas Ave 7

Singapore, 22 May 2014 – AIMS AMP Capital Industrial REIT (AACI REIT) today announced that it had entered into an agreement with its tenant Aalst Chocolate Pte Ltd to undertake customised asset enhancement initiative (AEI) at 26 Tuas Avenue 7.

The two-storey building, valued at \$10.3 million¹, is currently a purpose built factory with mezzanine office space. After the AEI, the factory will have an additional production line and extra storage space.

AACI REIT's manager Chief Executive Officer, Koh Wee Lih said: "We are pleased to partner with our long term tenant, Aalst Chocolate, to support their business and enhance the property to meet their growing needs.

"Our asset management team created a customised property solution that improves production capacity for Aalst Chocolate, while at the same time enhances the asset's value and delivers positive investment returns for unitholders – it's a win-win for everyone."

Chief Executive Officer of Aalst Chocolate Pte Ltd, Richard Lee said: "As the largest wholesale chocolate manufacturers and distributor in Singapore, we export high quality chocolate to food manufacturers throughout Asia and the Middle East.

"Over the last five years we have experienced rapid growth, and we need to expand our production line to keep pace with growing demand," Mr Lee said. "Responding to our needs, the manager of AIMS AMP Capital Industrial REIT developed a good solution that supports our business growth and meets our financial objectives."

By providing a customised property solution, the tenant will extend the current 10 year leasing term for another five years, until 18 April 2022, with agreed stipulated rental escalations in the new lease terms.

Annual rental income will rise from current S\$0.87 million to S\$1.05 million at the start of new term, providing a return on investment of 10 per cent.

The AEI will cost \$1.19 million, and will be funded from proceeds from the recent rights issue.
