On 17 January 2019, 1,619,540 units in AIMS AMP Capital Industrial REIT ("Units") were issued to AIMS AMP Capital Industrial REIT Management Limited ("AACIM" or "Manager") at an average issue price of S\$1.3757 per Unit ("Issue Price"), as partial payment of the base fee component of the Manager's management fee ("Base Fee") for the period 1 July 2018 to 31 December 2018.

In accordance with the AIMS AMP Capital Industrial REIT's Trust Deed, the Issue Price was determined based on the volume weighted average traded price for a Unit for all trades completed on the Singapore Exchange Securities Trading Limited, in the ordinary course of trading, for the last 10 business days of the relevant period in which the Base Fee accrues.

Following the above-mentioned issue of Units, the total number of Units in issue is 688,720,002 and the Manager now holds 1,619,540 Units.

As Great World Financial Group Pty Ltd ("GWFG") is the 50% indirect owner of AACIM and 100% owner of AIMS Financial Holding Limited ("AFHL"), GWFG is deemed to have an interest in the Units held by AACIM.
