Following the issue of the DRP Units, the number of issued Units in AA REIT have increased from 688,720,002 to 690,912,928.

Although there were no changes to the deemed interest held by Great World Financial Group Pty Ltd, Great World Financial Group Holdings Pty Ltd and Mr George Wang, there was a change in percentage of the deemed interest subsequent to the issue of DRP units.
