While Form C will be attached to the announcement template, it will not be disseminated to the public and is made available only to the Monetary Authority of Singapore (the "Authority").

On 28 June 2023, AFHL entered into a purchase agreement to acquire 3,400,000 units of AIMS APAC REIT at the unit price of \$1.22.

The two acquisition transactions settled on 6 July 2023.

GREAT WORLD FINANCIAL GROUP HOLDINGS PTY LTD ("GWFGH") is deemed to have an interest as it owns 100% of GREAT WORLD FINANCIAL GROUP PTY LTD ("GWFGPL"), which in turn owns 100% of AFHL.

As Mr George Wang is the ultimate owner of AFHL, GWFGH and GWFGPL, Mr George Wang is deemed to have an interest in those units above.
