Further to the announcement dated 10 March 2025, AIMS APAC REIT Management Limited, in its capacity as manager of AIMS APAC REIT ("**AA REIT**") (the "**Manager**"), wishes to announce that HSBC Institutional Trust Services (Singapore) Limited, in its capacity as trustee of AA REIT (in such capacity, the "**Issuer**"), has today issued S\$125 million 4.70 per cent. subordinated perpetual securities (the "**Series 004 Perpetual Securities**"). The Series 004 Perpetual Securities were issued under the S\$750,000,000 Multicurrency Debt Issuance Programme established by the Issuer on 30 November 2018 (the "**Programme**"). Oversea-Chinese Banking Corporation Limited acted as the sole lead manager and bookrunner for the issue of the Series 004 Perpetual Securities.

Approval in-principle has been received from the Singapore Exchange Securities Trading Limited (the "**SGX-ST**") for permission to deal in and the listing and quotation of the Series 004 Perpetual Securities on the SGX-ST. Such permission will be granted when the Series 004 Perpetual Securities have been admitted to the Official List of the SGX-ST. The SGX-ST assumes no responsibility for the correctness of any of the statements made or opinions expressed or reports contained herein. Admission to the Official List of the SGX-ST and quotation of the Series 004 Perpetual Securities on the SGX-ST is not to be taken as an indication of the merits of the Issuer, AA REIT, their respective subsidiaries, associated companies (if any) and/or joint venture companies (if any), the Programme or the Series 004 Perpetual Securities.

The Series 004 Perpetual Securities are expected to be admitted to the Official List of the SGX-ST with effect from 9.00 a.m. on 19 March 2025.
